SUBMARINE HISTORY

U.S.S. HERRING (SS-233)

U.S. SUBMARINE VETERANS OF WORLD WAR TWO, VOLUME FOUR, PAGE 341

“HERRING UNDER LT. CDR. D. ZABRISKIE JR., LEFT PEARL HARBOR 16 MAY, 1944 TO CONDUCT HER EIGHTH PATROL IN THE KURILE ISLANDS. ON 21 MAY SHE TOPPED OFF WITH FUEL AT MIDWAY AND DEPARTED FOR THE KURILE REGION. NO WORD WAS RECEIVED DIRECTLY FROM HERRING AFTER HER DEPARTURE FROM MIDWAY, BUT SHE DID ACCOMPLISH A RENDEZVOUS WITH BARB ON 31 MAY 1944.”

“THESE TWO BOATS WERE TO PATROL THE KURILE ISLANDS AREA COOPERATIVELY, AND AT THE RENDEZVOUS AS RECORDED IN BARB’S REPORT OF HER EIGHTH WAR PATROL, THE AREAS WHICH EACH WAS TO BE RESPONSIBLE FOR WERE DELINEATED. A FEW HOURS AFTER LEAVING HERRING EARLY IN THE AFTERNOON OF 31 MAY, BARB MADE CONTACT WITH TWO JAPANESE MERCHANTMEN. WHILE DEVELOPING THE CONTACTS BARB HEARD DISTANT DEPTH CHARGING, WHICH SHE TOOK AS AN INDICATION THAT HERRING WAS MAKING AN ATTACK.”

“LATER THAT EVENING BARB PICKED UP A PRISONER WHO REVEALED THAT HERRING HAD SUNK THE ESCORT VESSEL OF THE CONVOY BARB HAD BEEN ATTACKING. THE SHIP SUNK WAS ISHIGAKI, A NEW TYPE DE BUILT IN 1942, AND IT WAS SUNK WITH ONE TORPEDO HIT. THE SINKING RESULTED IN THE SCATTERING OF THE THREE SHIP CONVOY AND TWO SHIPS, WHICH SUBSEQUENTLY PASSED NEAR BARB, WERE SUNK BY HER. POST WAR INFORMATION REVEALS THAT HERRING SANK THE THIRD MERCHANTMAN OF THE CONVOY.”

“JAPANESE INFORMATION INDICATES THAT HERRING WAS SUNK ON 1 JUNE 1944, TWO KILOMETERS SOUTH OF POINT TAGAN ON MATSUWA ISLAND IN THE KURILES. THE REPORT STATES THAT TWO MERCHANT SHIPS, HIBURI MARU AND IWAKI MARU WERE SUNK BY AMERICAN TORPEDOES WHILE AT ANCHOR AT MATSUWA. IN A COUNTER-ATTACK A SHORE BATTERY SCORED TWO DIRECT HIT ON THE CONNING TOWER”....

“AS A RESULT OF THE ATTACKS REPORTED BY BARB AND BY THE JAPANESE, HERRING HAS BEEN CREDITED WITH FOUR SHIPS AND 13,202 TONS SUNK FOR HER LAST PATROL.”

U.S.S. HERRING (SS-233) COMMANDING OFFICERS

LCDR RAYMOND W. JOHNSON WAS THE COMMISSIONING AND THE FIRST TWO WAR PATROL’S COMMANDING OFFICER. UNDER ORDERS ISSUED BY COMMANDER SUBMARINE SQUADRON FIFTY, LCDR JOHN CORBUS TEMPORARILY RELIEVED LCDR JOHNSON ON MARCH 5TH 1943 (ONE DAY BEFORE HERRING GOT UNDERWAY FOR PATROL NUMBER 3). TEMPORARY COMMAND OFFICER, LCDR J. CORBUS WAS RELIEVED BY REGULAR COMMANDING OFFICER LCDR R.W. JOHNSON ON APRIL 13 1943 UPON HERRING’S

RETURN FROM THE THIRD PATROL. LCDR JOHNSON WAS COMMANDING OFFICER OF HERRING FOR HER 4TH, 5TH, AND 6TH PATROLS. ON 6 FEBRUARY, 1944, AT MIDWAY, LCDR D. ZABRISKIE RELIEVED CDR R. W. JOHNSON AS COMMANDING OFFICER. LCDR ZABRISKIE WAS THE LAST COMMANDING OFFICER OF THE HERRING (SS-233).

AS DESCRIBED IN THE PROLOGUE OF HERRING'S NOW UNCLASSIFIED REPORT OF FIRST WAR PATROL FOR THE PERIOD FROM OCTOBER 21 TO NOVEMBER 25, 1942, "HERRING WAS COMPLETED ON JUNE 10, 1942 AT THE NAVY YARD, PORTSMOUTH, NH"... HERRING THEN OPERATED LOCALLY, THEN OUT OF NEW LONDON, AND NEWPORT CONDUCTING TRAINING AND CHECKING OUT THE EQUIPMENT. "THE PERIOD JULY 24 TO OCTOBER 3, 1942 WAS SPENT AT THE TORPEDO STATION, NEWPORT, DURING WHICH TIME A TOTAL OF 403 SPECIAL FIRINGS WERE CONDUCTED." HERRING THEN RETURNED TO NEW LONDON FOR UPKEEP, AND ROUTINE REPAIRS, IN PREPARATION FOR "BECOMING A PART OF SUBMARINE SQUADRON FIFTY"... "ON OCTOBER 18, 1942 HERRING REPORTED READINESS FOR EXTENSIVE WAR OPERATIONS."

"FOR HER FIRST SEVEN PATROLS, HERRING SANK NINE SHIPS, TOTALING 45,200 TONS, AND DAMAGING TWO, TOTALING AN ADDITIONAL 8,400 TONS."

HER FIRST FIVE PATROLS WERE CONDUCTED IN THE ATLANTIC. THE FIRST, COMMENCING UPON DEPARTURE FROM NEW LONDON AND ENDING AT BASE II ROSENEATH, SCOTLAND, WAS OFF OF CASABLANCA, FRENCH MOROCCO. OPERATING OUT OF ROSENEATH FOR THE 2ND, 3RD, & 4TH PATROLS, THE SECOND AND THIRD PATROLS WERE OFF OF SPAIN IN THE BAY OF BISCAY, THE FOURTH NORTH OF ICELAND, AND HER LAST ATLANTIC PATROL WAS DURING THE TRANSIT BACK TO NEW LONDON FROM SCOTLAND. SHE SANK A U-BOAT ON HER THIRD PATROL BUT WAS GIVEN ONLY A "PROBABLE" AS NO CONFORMATION WAS MADE. HERRING THEN MADE HER WAY TO PEARL AND HER SIXTH PATROL WAS IN THE EAST CHINA SEA WHERE SHE "SANK TWO LARGE TRANSPORTS, A FREIGHTER, AND A SMALL ESCORT TYPE VESSEL." HERRING'S SEVENTH PATROL COMMENCED AT MIDWAY, PATROLLING IN THE AREA JUST SOUTH OF THE JAPANESE HOME ISLANDS WHERE SHE DAMAGED A DESTROYER TYPE VESSEL.

AS DESCRIBED IN HER FIRST WAR PATROL REPORT, THE PATROL COMMENCED ON OCTOBER 20, 1942 WHEN SHE "TOOK DEPARTURE FROM POINT SEVEN MILES EAST OF MONTAUK LIGHT AT 2001 (Q)"... HER PATROL AREA WAS TO BE "CASABLANCA, FRENCH MOROCCO, AND PATROL LANE CAPE SIM TO MADEIRA." HERRING WAS TO SUPPORT THE NORTH AFRICA LANDING THAT WOULD COMMENCE NOVEMBER 8, 1942. HERRING ARRIVED ON STATION ON NOVEMBER 5 WHEN IN THE PATROL REPORT WORDS: "1853 (Z) SURFACED SEVEN MILES OFF CASABLANCA AND HAD THE IMPRESSION THAT WE HAD COME UP IN THE CENTER OF TIMES SQUARE. THE CITY WAS LIGHTED UP BRILLIANTLY EXCEPT FOR DAR EL BEIDA LIGHT WHICH WAS EXTINGUISHED. ILLUMINATION TO SEAWARD SILHOUETTED EVERY OBJECT ON THE SURFACE INCLUDING SMALL CRAFT..." "IT WAS NO PLACE TO LOITER IF DETECTION WERE TO BE AVOIDED, SO

SET COURSE TO THE NORTHWESTWARD AT 15 KNOTS TO GET CLEAR.”

THE FOLLOWING ARE EXTRACTS OF THE PATROL REPORT NARRATIVE FOR THE LAST PART OF THE NOVEMBER 7TH AND 8TH DURING THE COMMENCEMENT OF THE NORTH AFRICA ATTACK DURING WHICH HERRING SANK HER FIRST SHIP:

NOVEMBER 7 – “WHEN ABOUT TO SURFACE AT 1904 (Z) OBSERVED SEVERAL LIGHTS OF SMALL CRAFT IN IMMEDIATE VICINITY. CHANGED COURSE TO 320°T., AND WHEN CLEAR SURFACED AT 1955 (Z), EIGHT MILES BEARING 306°T. FROM DAR BEIDA LIGHT. THE SITUATION AT THIS TIME WAS SIMILAR TO THAT OF PREVIOUS EVENINGS – BRILLIANT ILLUMINATION FROM THE SHORE LIGHTS, AUGMENTED BY DAR EL BEIDA LIGHT, WHICH WAS SHOWING NORMAL, UNDIMMED CHARACTERISTICS. SEVERAL SMALL CRAFT WITH SINGLE LIGHTS WERE DISTINGUISHABLE AGAINST THE BACKGROUND OF THE CITY. HERRING’S DIRECTIVE AT THIS TIME WAS TO REMAIN WITHIN FOUR MILES OF THE COAST OFF CASABLANCA FOR THE REMAINDER OF THE NIGHT. THE SITUATION WAS CONSIDERED TO JUSTIFY A DEPARTURE FROM THIS DIRECTIVE, PROVIDED THE OFFENSIVE NATURE OF THE PATROL COULD BE MAINTAINED. IT HAD BEEN PREMISED, PRESUMABLY, ON THE CITY BEING BLACKED OR DIMMED OUT, WITH NO NAVIGATIONAL LIGHTS BURNING, AND AN OFF-SHORE PATROL OF LIMITED SCOPE. DECISION WAS MADE TO PATROL IN AND OUT ON DAR EL BEIDA ON SHORT LEGS, CLOSING IN GRADUALLY AS ILLUMINATION BECAME LESS PRONOUNCED, AND TO AVOID ANY INTERFERENCE WITH OWN FORCES ARRIVING ABOUT DAWN. THIS POSITION WAS SUCH THAT WATERFRONT LIGHTS PROVIDED A GOOD BACKGROUND FOR SIGHTING ANY SHIPPING DEPARTING FROM THE HARBOR, AND THE LIGHT ON THE CAPE WOULD AMPLY SILHOUETTE SOUTHWESTERLY COASTAL SHIPPING, COMPELLED BY SHOAL TO CLEAR IT BY ABOUT TWO MILES.”

“2300 (Z) PICKED UP SUPERSONIC PINGING AT SIX-SECOND INTERVALS BEARING 340°T., AND ALSO DETECTED RADAR EMISSIONS ON SJ FROM SAME GENERAL DIRECTION, INDICATING APPROACH OF OWN FORCES.”

“2349 (Z) DAR EL BEIDA LIGHT EXTINGUISHED.”

NOVEMBER 8 – “0100 (Z) CHANGED COURSE TO 150°T., CLOSING ON APPROXIMATE POSITION OF DAR EL BEIDA LIGHT. TBS COMMUNICATIONS BETWEEN SHIPS STARTED TO COME IN ABOUT THIS TIME, VERY FAINT AND INDISTINCT.”

“0130 (Z) IN POSITION WITHIN FOUR MILES OF DAR EL BEIDA LIGHT, COMMENCED PATROLLING ON COURSE 240°T. AND REVERSE. HEARD INTERMITTENT COMMUNICATIONS OVER TBS ABOUT 0245 (Z) DELAYING H HOUR A TOTAL OF 45 MINUTES, SOURCE INDISTINGUISHABLE.”

“0320 (Z) CASABLANCA BLACKED OUT SUDDENLY EXCEPT FOR A FEW SCATTERED LIGHTS ALONG WATERFRONT.”

“0355 (Z) OBSERVED AN ALERT SIGNAL OF SOME SORT FROM VICINITY OF GRANDE JETTY. SIGNAL CONSISTED OF THREE QUICK, GREEN FLASHES, CHARACTERISTIC OF PHOTOFLASH BULBS, EMANATING FROM THREE TOWERS CLOSE TOGETHER.”

“0400 (Z) AUTHORITY NOW EXTENDED TO DESTROY ANY VESSEL DEPARTING FROM CASABLANCA.”

“0500 (Z) SUBMERGED ON COURSE 250°T. IN POSITION 4 MILES BEARING 327°T. FROM DAR EL BEIDA LIGHT AND COMMENCED WITHDRAWAL FROM AREA AS DIRECTED.”

“0601 (Z) SIGHTED LIGHTS BEARING 025°T., DISTANT 4 – 5 MILES.”

“0700 (Z) SIGHTED MASSACHUSETTS AND CRUISERS TO NORTHWARD WITH DESTROYER SCREEN, FIRING ON CASABLANCA. OBSERVED RETURN FIRE OF ABOUT 5” OR 6” CALIBER FROM SHORE BATTERY AT AUNK PROMONTORY.”

“0711 (Z) SIGHTED SINGLE PONTOON OBSERVATION PLANE TO NORTHEAST ABOUT 1000 YARDS RANGE. INCREASED DEPTH TO 100’. ENDEAVORED TO GET PERISCOPE PICTURES OF FIRING WHILE WITHIN REASONABLY CLOSE RANGE BUT LIGHT CONDITIONS WERE POOR.”

“MAINTAINED CONSTANT WATCH FOR DEPARTURE OF ANY SHIPPING FROM THE PORT. GUNFIRE FROM MAIN BATTERIES SENT A STRONG METALLIC REPORT THROUGHOUT THE HULL, SIMILAR TO DISTANT DEPTH CHARGING, WHILE SECONDARY BATTERIES PRODUCED A CONTINUAL CLATTER OF LESSER INTENSITY.”

“0716 (Z) CHANGED COURSE TO 230°T., TO MOVE FURTHER CLEAR OF ASSAULTING FORCES ESTIMATED TO BE ABOUT FIVE MILES DISTANT.”

“0848 (Z) CHANGED COURSE TO 250°T., TO PARALLEL COAST AT A DISTANCE OF 4 ½ MILES.”

“0936 (Z) SIGHTED WHAT APPEARED TO BE A MERCHANTMAN BEARING 087°T., DISTANCE 8 MILES. VESSEL WAS STANDING DOWN FROM CASABLANCA AND HAD ROUNDED THE CAPE CLOSE ABOARD, CAMOUFLAGED BY THE HILLS IN BACKGROUND. DECIDED TO HOLD COURSE TEMPORARILY TO KEEP HIM INSHORE OF US SINCE AN ATTACK TO THE NORTHWARD MIGHT BRING US TOO CLOSE TO OWN FORCES.”

“1003 (Z) WENT TO BATTLE STATIONS AND COMMENCED APPROACH ON NORMAL APPROACH COURSE, HIGH SPEED. VESSEL WAS ZIGZAGGING LIMITED AMOUNTS, BEING RESTRICTED BY PROXIMITY TO COAST.”

“1043 (Z) MANEUVERED TO FIRING COURSE FOR 70°STARBOARD TRACK.

IDENTIFIED SHIP BY COLORS (FRENCH) AND NAME ON SIDE VILLE DUE HAVRE.”

“1052 (Z) FIRED TWO TORPEDOES FROM BOW NEST, RANGE 1200 YARDS. NO. 1 HIT UNDER BOW SLIGHTLY FORWARD OF FOREMAST KNOCKING OFF PART OF BOW. NO.2 MISSED, POSSIBLY AHEAD, ALTHOUGH IT APPEARED TO PASS UNDER THE SAME SPOT. VESSEL WAS COMING TO STOP AND SWINGING RIGHT SLOWLY.”

“1054 (Z) FIRED NO. 3 TUBE WHICH WAS NOT HEARD TO RUN AND NO TRACK SEEN. EXECUTED FULL LEFT RUDDER TO BRING STERN TUBES TO BEAR FOR A STRAIGHT SHOT. DROPPED TARGET SPEED TO ZERO.”

“1101 (Z) FIRED NO. 7 TUBE WHICH HIT ABOUT TWENTY YARDS INSIDE STERN AND TWISTED STERN UPWARD SOME TEN DEGREES. VESSEL STARTED SETTLING SLOWLY, LIFE BOATS WERE MANNED AND LOWERED AND GENERAL ABANDONMENT IN PROGRESS. SINCE WE WERE ONLY TEN MILES FROM THE CASABLANCA AIRPORT, DECIDE TO CLEAR THE AREA AS QUICKLY AS POSSIBLE. STOOD OFF ON COURSE NORTH AT SIX KNOTS, DEPTH 100’.”
