# **Submarine Ferry and Evacuation Services in Early WWII**

During my research for a previous history presentation on U.S.S. SHARK, I came across an archived report dated April 1, 1942 describing the "War Activities SUBMARINES, U.S. ASIATIC FLEET, December 1, 1941 – April 1, 1942" from "The Commander Submarines, U. S. ASIATIC FLEET" to "The Commander in Chief, U.S. FLEET and Chief of Naval Operations" via "The Commander U.S. Naval Forces based in Western Australia". The discovered report is extremely long and contains 48 paragraphs, some filling two to three 8.5 X 11 pages and each paragraph describing different topics. The contents of this history presentation is from paragraph 1 and paragraph 37 of the archived report.

1. "On December 1, 1941 Submarine Squadron TWO and TWENTY were reorganized into Submarines, U. S. ASIATIC FLEET, dispensing with the Squadron echelon and under the command of Captain W. E. Doyle, U.S.N. This officer had just recently been Commander Submarine Squadron Two and had brought his Squadron from Pearl Harbor to Manila, arriving during November in two groups. The new organization was composed of the following units at that time present and based on Manila Bay:"

{The following is a subset (because of presentation time limits) of the contents of the source document paragraph 37 relating to the use of units for evacuation and ferry services.}

37. "In addition to the other activities described herein, ever since the first of the year, this Command has been continuously attempting to satisfy numerous demands from other sources for submarines for various evacuation and ferrying trips. Since early January and average of two submarines have been continuously diverted for these purposes. From the nature of the requests it has been obvious that the outside sources which request them have not done so with the full realization of how much this has taken away from potential offensive capabilities of this unit. Both Admirals Hart and Purnell have continuously opposed these demands in order to keep our offensive operations at a maximum."

"On 16 January SEAWOLF departed Darwin on a similar expedition with a cargo of anti-aircraft ammunition. Thirty-seven tons was all that could be obtained from Army authorities for this trip. SEAW0LF arrived Corregidor evening of 27 January and departed the following day."

"SEADRAGON, then on patrol off the Indo-China coast, was dispatched to Corregidor primarily for the purpose of evacuation nineteen member of the Radio Intelligence unit during her return south."

"On 13 February the High Commissioner, Mr. Sayre, requested Admiral Hart to send a submarine for evacuation of himself, family, and staff, totaling eleven persons. A reply was sent back from Bandoeng to the effect that this could be accomplished at any time on three days notice. The High Commissioner requested one immediately, and since SWORDFISH was then on patrol off Surigao and the closest one of our submarines to Manila at that time, she was designated to go up for this purpose. On 14 February Admiral Hart told Mr. Sayre that he regretted that accommodations were insufficient for the entire staff and that the party must be

limited to four in order to allow for evacuation of naval personnel much needed in other theatres of war. Upon arrival SWORDFISH was used, at the end of February to first make a shuttle trip to Panay with President Quezon and party and then return for Mr. Sayre. His entire party of eleven was embarked, necessitating reduction of the naval personnel desired to be evacuated at that time." "On 26 February the Navy Department directed that one submarine be always kept at the disposal of General MacArthur and that submarines that were used for this purpose were to take in maximum quantities of ammunition. It was at first planned to send SPEARFISH from Surabaya, arriving about 13 March, and General MacArthur was informed that she must return immediately due to time already spent at sea but would be relieved by PERMIT later. He was also told that the question of whether or not PERMIT carried ammunition would depend on availability of a loading port in Java and that she would patrol off the Bataan coast until needed by the General. Events in the Java Sea prevented execution of this plan and on 28 February PERMIT was directed to proceed from her patrol station north of Java direct to Luzon without being able to be filled with ammunition." "About this time request from British authorities was received for rescue of a party of forty, including Rear Admiral Spooner and an Air Marshall from Singapore, who were reported stranded on Chebia Island. S-39 was designated, made a landing on the island but the party had vanished before his arrival."

"SARGO, STURGEON and SEADRAGON were used for evacuation of naval personnel from Java when the collapse appeared imminent."

"Instead of bring out General MacArthur and party, PERMIT was used as a standby should his plan for plane evacuation fail."

"Meanwhile, on 5 March, the Commander is Chief directed that all remaining personnel of the Radio Intelligence unit at Corregidor be evacuated as soon possible. Based on this the Commandant Sixteenth Naval District utilized PERMIT, loading her with forty-seven people in addition to the ones she already had on board and, unknown to this command, directing her to conduct a patrol through Verde Island Passage and in the vicinity of Marinduque. Previous directives from this command had limited total number of passengers to twenty-five and on this occasion the Commanding Officer, PERMIT should have protested the carrying of a total of one hundred and eleven persons in his ship. The situation was complicated a short time later when she was required by the presence of enemy anti-submarine units to stay down a total of thirty-seven hours out of thirty-eight. All of this occurred unknown to this command because on 16 March Commandant Sixteenth District had specifically reported that an offensive patrol by PERMIT was not desired."

"On 7 March a message was sent to SWORDFISH directing that all passengers and others on board be impressed before arrival with the fact that revelation of the nature of her recent trip would jeopardize similar future expeditions. This was

carefully complied with and as far as known Mr. Sayre and party did not reveal on arrival in the United States that they had been evacuated by submarine. This precaution was, however, nullified a few days later when Army authorities revealed PERMIT's activities in connection with the evacuation of General MacArthur."
